(Authorization for operating a facility for Collection, Transport of Biomedical Wastes)

- 1 Authorization Letter No. BMW/2022-2023/BMW/BMW/18.
- 2 Jitendra Sharma, CEO of JRR Waste Management Pvt. Ltd.(Old Name Datt Enterprises Limited) is hereby granted an authorization under Rule 10 of Bio-Medical Waste (Management & Handling) Rules, 2016 (BMW Rules, 2016) to operate a facility for Collection, Transport of biomedical waste on the premisses situated at Dholpur, , Tehsil Dholpur, District Dholpur.
- 3 This authorization shall be in force for a period from 26/06/2022 to 31/05/2027.
- 4 This authorization is valid for operation of the Transporter of BMW with 0 (zero) number of beds.
- This authorization is subject to the conditions contained in enclosed annexure and to such other conditions/guidlines as may be specified under BMW Rules, 2016 by Central Pollution Control Board, Delhi or Ministry of Environment & Forests(MoEF), Government of India (GOI) or Department of Environment (DOE), Government of Rajasthan (GOR).
- 6 Segregation, packing, transportation, storage, treatment & disposal of bio medical waste shall be in accordance with Rule 7 & 8 of BMW Rules, 2016. The bio medical waste shall be disposed of at Common Biomedical Waste Treatment & Disposal Facility (CBMWTDF) established for the area viz .
- The mercury bearing waste arising due to breakage of thermometers, pressure gauges and other instruments is not to be treated as bio-medical waste or other solid waste. The mercury bearing waste is to be segregated, collected, stored and disposed in accordance with the provisions of Hazardous Waste and other wastes (Management and Transboundary Movement) Rules, 2016.
- The Annual report in accordance with Rule 13 for the period 1st January to 31st December of previous year shall be submitted On or before 30th June of every year in form IV as prescribed in the Rules and the annual report shall also be made available on the web-site of the occupier. Further, all the health care facilities shall develop their website within two years from the date of notification of the BMW Rules, 2016, in case not already developed.

- 9 The hospital shall maintain the record of biomedical waste as per Rule 14 & shall be produced during the inspection.
- 10 That the hospital shall phase out use of chlorinated plastic bags, gloves and blood bags within two years from the date of notification of the BMW Rules, 2016.
- 11 That the hospital shall establish a Bar-Code System for bags or containers containing bio-medical waste to be sent out of the premises or place for any purpose within one years from the date of the notification of the BMW Rules, 2016.
- That the hospital shall provide training to all its health care workers and others, involved in handing of bio-medical waste at the time of induction and thereafter at least once every year and the details of training programs conducted, number of personnel trained and number of personnel not undergone any training shall be provided in the Annual Report.
- The application for renewal of authorization shall be submitted online in prescribed form along with requisite fee, affidavit, assessment format, annual report & copy of valid agreement with CBMWTDF at least 120 days before the date of expiry of this authorization.
- In case of expansion in bed capacity or increase in pollution load, the hospital shall obtain prior Consent to Establish under Water (Prevention and Control of Pollution)Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 & revised Authorization under BMW Rules, 2016.
- 15 That the hospital shall comply the provisions of Bio-medical Waste Management Rules, 2016.
- 16 That the hospital shall comply with the standards for treatment and disposal of Bio-medical Waste as specified under schedule II of Boi-medical Waste Management Rules, 2016.
- 17 That infected hospital liquid waste must be given chemical treatment by using at least 10% hypochlorite solution or any other equivalent chemical reagent to ensure required disinfection as prescribed in part-2 of schedule-I of the Rules.

- 20 That CBMWTDF shall comply bar coding system for handling of bio-medical waste in accordance with the guidelines issued by Central Pollution Control Board.
- That CBMWTDF shall get renewed the authorization and consent to operate from UPPCB for treatment and disposal of BMW time to time and submit a copy of the same to this office as well as Regional Office, Bharatpur.
- 22 That CBMWTDF shall inform the State Board immediately regarding the occupiers which are not handing over the segregated bio-medical waste in accordance with BMW Rules 2016.
- That CBMWTDF shall transport the bio-medical waste from the premises of an occupier to your bio-medical waste treatment facility only in the vehicles having label as provided in part 'A' of the Schedule IV along with necessary information as specified in part 'B' of the Schedule IV of BMW Rules 2016.
- That this authorization is limited to transportation of bio-medical waste from the HCF's located in District- Dholpur to the Common Biomedical Waste Treatment Facility located in Agra.
- 25 That CBMWTDF shall display details of authorization, consent, treatment and annual report etc. on CTDF's website as per rule 5(l) of BMW Rules, 2016 & amendments thereof.
- That all the duties of the operator of CBMWTDF as enunciated under Rule 5 of the BMW Management Rules, 2016 shall be ensured & complied with.
- 27 That the hospital shall maintain record of collection, storage and transportation bio-medical waste to Common **Bio-Medical** Waste Treatment and Disposal **Facility** (CBWTDF) for disposal. The quarterly abstract related to the collection. storage. transportation and disposal shall be submitted to the H.O. and Regional Office in the format given below:
